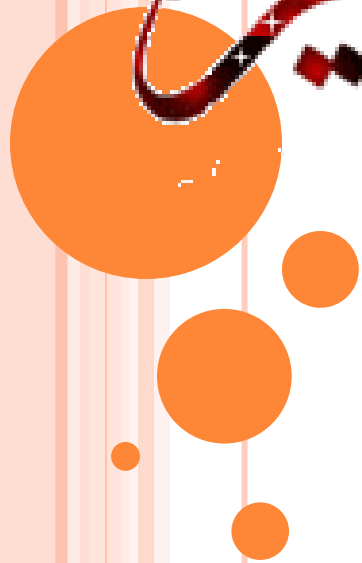

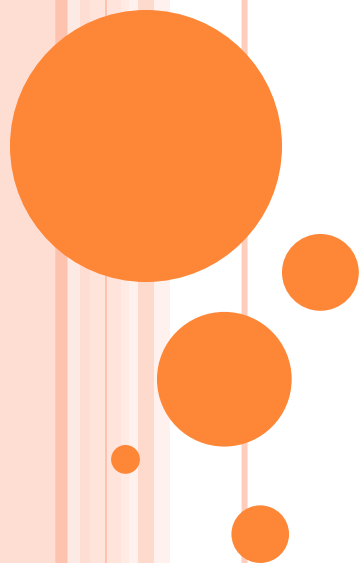

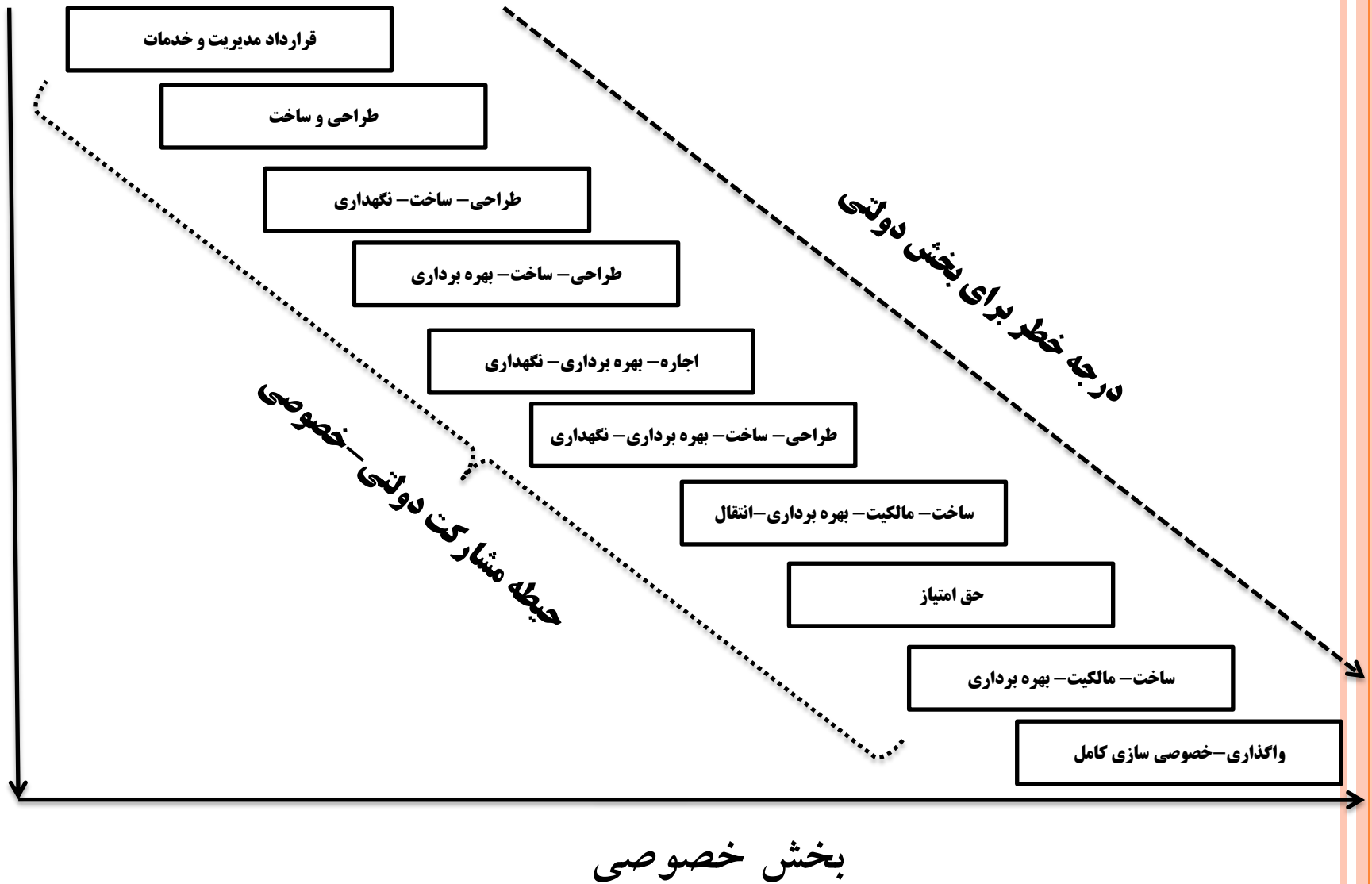

# Public private partnership in in-service training of physicians: the millennium development goal 6-partnership for African clinical training (M-PACT) approach

**Obinna Ositadimma et al, West Africa, 2018**

## **Methods:**

- The RCP and WACP initiated the M-PACT program with funding obtained from Eco Bank Foundation
- 681 physicians from across the West African region
- medical leadership, malaria, tuberculosis and HIV/AIDS
- pre-and post-course testing, as well as daily and summative assessment to evaluate the courses.
- a six-month post-training evaluation

## **Results:**

- positive participant feedback
- clinical practice of participants on prescription patterns, diagnostic approaches and case finding
- a decline in incidence and mortality due to malaria, HIV and TB
- significant impact on subsequent clinical practice, as demonstrated by the 6-month post-training review
- improved patient outcomes

## Methods:

1. Evaluation of the performance of PPP projects: a literature review:

- respect for timely delivery and costs,
- innovation,
- service quality and
- life cycle costing;

2. ESPC: a case study (after implementation):

## Methods:

- Review papers relevant to PPP published in the six leading construction management journals
- 1998 to 2007
  - case studies= 57
  - Surveys= 43
  - Literature reviews= 34
  - Workshops papers= 2
- 85 studies related
